Organizing Authority: Yacht Club de Cannes

1. RULES

The Regatta will be governed by:

- **1.1.** Rules as defined in *The Racing Rules of Sailing*,
- **1.2.** National prescriptions for foreign competitors are defined in joined appendix named "prescriptions"
- **1.3.** Federation regulations
- **1.4.** If there is a conflict between languages, the French text will take precedence.

2. ADVERTISING

In accordance with ISAF Regulation 20 (Advertising Code) as modified by the Advertising regulation of the FFVoile, boats may be required to display the advertising chosen and supplied by the organizing authority.

3. ELIGIBILITY AND ENTRY

3.1. The regatta is open to all boats from the following series FINN.

3.2 Eligible boats may enter by completing the entry form and sending it, together with the required fee to "Yacht Club de Cannes", no later than February 11^{th} .

3.3 Competitors (each crew member) living in France shall present during registration:

- the valid and signed FFVoile's licence with health certificate and a parents' permission for the minors,
- A valid authorization to display advertising on boat, if necessary
- The measurement form or certificate of the boat,

Foreign competitors without a French licence shall justify their membership to an ISAF Member national authority.

4. ENTRY FEES

The entry fee will be as follows: **75.00**€ The preregistrations will have to reach the "Yacht Club de Cannes" before **February 11th, 2011** After this date set-up fees will be **85.00**€ **The number of participants is limited to 150 boats**

7. MEASUREMENT

Pre race measurement operations will be made from February 14th at 9.00am to February 15th at 18.00pm, location: in the sailing school.

8. SAILING INSTRUCTIONS

The sailing instructions and their appendices will be

available during confirmation of registration on February 14th and 15th,

9. THE COURSES

Courses to be sailed will be as follows: geometrical.

10. SCORING

- **10.1.** 2 races are required to be completed to constitute a series.
- 10.2. Scoring system used is the Low Point System.

11. RADIO COMMUNICATION

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

13 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. Decision to race or to continue racing is their own responsibility.

The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the regatta.

14 INSURANCE

Each foreign competitor without FFVoile licence shall be insured with a valid third-party liability insurance with a minimum cover of 1 500 000 Euros.

FFVoile Prescriptions to RRS 2009 – 2012 Applying to foreign competitors

RRS 64.3 (*):

Jury may ask the parties to the protest, prior to checking procedures, a deposit covering the cost of checking arising from a measurement protest.

RRS 68 (*):

Any claim for damages arising from an incident involving a boat bound by the RRS shall be subject to the appropriate courts and will not be considered by the jury.

RRS 70. 5 (*):

In such circumstances, the written approval of the FFVoile shall be received before publishing the notice of race and shall be posted on the official notice board during the competition.

RCV 86.3 (*):

An organizing authority wishing to change a rule listed in RRS 86.1 in order to develop or test new rules shall beforehand submit the changes to the FFVoile, in order to obtain its written approval and shall report the results to FFVoile after the regatta. The authorization of the FFVoile shall be mentioned in the notice of race, in the sailing instructions, and shall be posted on the official notice board during the regatta.

RRS 88 (*):

Prescriptions of the FFVoile shall be neither changed nor deleted in the sailing instructions, except for competitions for which an international jury has been appointed.

In such case, the prescriptions marked with an asterisk (*) shall be neither changed nor deleted in the sailing instructions. (The official translation of the prescriptions, downloadable on the FFVoile website www.ffvoile.org, shall be the only translation used to comply with RRS 90.2(b)).

RRS 91 (*):

The appointment of an international jury meeting the requirements of Appendix N is subject to prior written approval of the FFVoile. Such notice of approval shall be posted on the official notice board during the event.
